

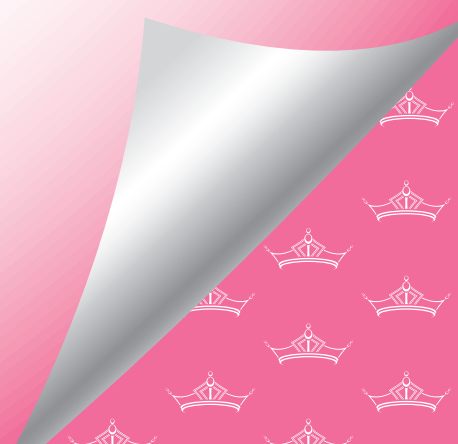

1. WHAT IS A SALUTE PAGE AD?

A salute page ad is an advertisement page in our official program book dedicated to you, the contestant. This ad reflects what the contestant is all about. Personality, platform, education, talent, the possibilities are endless. The Salute Page Ad is wonderful way for home town businesses, friends, family and relatives to show their support for you and your endeavor to become Miss Oklahoma's Outstanding Teen 2012!

2. HOW DO I SELL THESE ADS?

You should sell these ads with the idea that it is a WIN-WIN opportunity. People from all over the state will see these ads promoting the contestant. The contestant in turn will receive a rebate from the ads sold. The exposure from a marketing value is priceless.

3. HOW MANY ADS SHOULD I EXPECT TO SELL?

Each title holder should be able to sell a minimum of 3 ads. The rebates do not come until 5 pages are sold. In the past, some titleholders have sold over 35 pages! Check out our enclosed rebate and prize package list to see how this could benefit you the most!

4. WHO DO I CONTACT?

Anyone can be a prospect. Family, teachers, business owners, chamber representatives, employers, friends, college representatives, sororities, or community leaders.

5. WHAT IS MY FIRST STEP IS SELLING A SALUTE PAGE AD?

- a. Contact sponsor
- b. Explain why you are selling these ads
- c. Make a presentation about the Miss America Program and the benefits you gain from participating in the program.
- d. conclude your presentation and ask the sponsor if they will participate with you by purchasing an ad.

6. WHAT IS THE COST?

A full page color ad is \$750.00.

A full page black/white ad is \$300.00.

*If you sell one ad page to multiple sponsors, have each sponsor write their checks to your local pageant. Then have your local pageant write one check to the Miss Oklahoma Pageant.

*Ideally, one check for all ads should be submitted.

7. HOW MANY PEOPLE WILL VIEW THIS AD?

Tens of thousands of people will see the ad not only in Oklahoma but Kansas, Texas, Arkansas, Missouri and throughout the entire country!

8. WHAT ARE THE 6 STEPS FOR COMPLETING EACH AD?

- a. complete order form
- b. complete salute page checklist
- c. attach payment in the form of check or money order made payable to the Miss Oklahoma Pageant, or all cash.
- d. attach photo(s) or disk(s)- Please use paper clips. Do not staple, tape or glue. Separate photos and/or disks must be supplied for each ad.
- e. place in 9 x 12 envelope with contestant name and title listed on the outside of the envelope. Complete final tally sheet and bring all ad page envelopes to Contestant's Day on April 14, 2012.
- f. Please number each of the envelopes in the order you wish for them to appear.

9. DO THE ADS ALL HAVE TO ARRIVE TOGETHER?

Yes, all ads must be turned in on Contestant's Day.

NOTE: THE DEADLINE FOR ADS AND CHECK IS APRIL 14, 2012

10. HOW SOON CAN I EXPECT MY REBATE CHECK?

Rebate checks will be mailed after May 10 , 2012 as long as all monies have been collected and cleared the bank.

TECHNICAL REQUIREMENTS FOR PROVIDED ELECTRONIC FILES

- Final page size: 8 1/2" X 11"
- 1/8" bleed (meaning any artwork that goes to the edge of the page must continue at least 1/8" past the edge of the page).
- All artwork for B/W ads should be in grayscale, 300 dpi. Any artwork in color will be converted to grayscale.
- All artwork for Color ads should be in CMYK, 300 dpi.
- Please provide a printout of the layout to ensure proper output.
- Files must be on CD-R or DVD-R.

ACCEPTABLE FILE FORMATS

PDF or EPS - Please save as high resolution and press-ready. Photos and graphics must be at least 300 dpi and all fonts must be embedded.

JPEG or TIFF - Must be actual size and at least 300 dpi in grayscale or CMYK mode. We recommend saving JPEGs as high quality.
